JCVS History

JCYS has responded to the varying needs and shifting demographics in the Chicagoland area throughout its long history. Though our programs continue to change and evolve to meet the demands of the community, our commitment and dedication to service—and to those we serve—remains constant and is what has sustained this agency for more than a century.

JCYS—first known as "Young Men's Associated Jewish Charities" and later as "Young Men's Jewish Council"—was founded. The agency's initial purpose was to engage a group of young male leaders in securing financial support for various Jewish charities and philanthropies in Chicago.

While the leadership experience continued to be a key part of the agency's mission, JCYS sought a new direction—to directly serve the youth of Jewish immigrants who desperately needed social and recreational services. The organization chose to pursue this goal through outdoor recreation and camping, establishing Camp Wilson near Long Lake, IL on land owned by the Chicago, Milwaukee & St. Paul Railway.

After purchasing 40 acres of land on Wooster Lake so that the summer camp could thrive in a home of its own, the agency recognized the growing need for city programs during the school year. Activities included championship teams in baseball, wrestling, track, ping-pong, and debate.

1940s Upon the passing of Illinois Governor Henry Horner, who was Young Men's Jewish Council president in 1915 and integral to the summer camp's beginnings, JCYS's summer camp on Wooster Lake was renamed "Camp Henry Horner" in his honor.

Women started to play a larger role in the workforce and JCYS responded by adding preschool programs and parent-child activities. The agency experienced significant growth with the addition of the George W. Lutz Family Center in Highland Park and the Michael R. Lutz Family Center in Lakeview.

1989The agency changed its name from "Young Men's Jewish Council" to "Jewish Council for Youth Services" to honor the growing role of women in the organization and to better reflect the age group most served through its programs.



1990s	The agency acquired the former Elms Swim & Tennis Club in Highland Park, renovated it, and renamed it the Lillian L. Lutz Recreation Center.	
2000s	Extending the reach of agency services, Northwest Family Center in Buffalo Grove opened as an early childhood education center, offering infant care for the first time in JCYS history.	
2016	The new Michael R. Lutz Family Center opened in Chicago's growing Wicker Park neighborhood, becoming the only Jewish institution in the area to provide early childhood services.	
2018	Strengthening its tradition of volunteer service and leadership development, the agency launched the JCYS Leadership Circle, a formal leadership development program for the Board of Directors.	
2019	The JCYS Board of Directors approved the sale of Camp Henry Horner to Camp Nageela, a Jewish camping organization. This sale included both the camp site and the Camp Red Leaf program, marking a significant transition in the agency's history. The Iris & Steven Podolsky Family Center was built and opened in the heart of Chicago's Lincoln Square and Ravenswood neighborhoods, hosting the beloved staff and programming from the former Michael R. Lutz Family Center in Lakeview.	
2022	JCYS successfully returned to pre-pandemic operation levels across all family centers. With the Board of Directors' approval, the agency conveyed its interest in the Lillian L. Lutz Recreation Center to Agudath Israel of Illinois, strengthening a partnership with Chicagoland's greater Jewish community.


Early Childhood Education

JCYS Family Centers provide a nurturing educational environment for children and a supportive community for families to learn and grow together. We are proud to provide infant care (6 weeks – 14 months), toddler care (15 – 23 months), and preschool (2 – 5 years) programming to families in Buffalo Grove, Highland Park, Lincoln Square Ravenswood, and Wicker Park.

Our early childhood education programs are grounded in play-based and Reggio curriculums, designed to nurture each child's spirit, imagination, and confidence. Essential to our curriculum are the Jewish values of Tikkun Olam (repairing the world), Tzedakah (social justice and charity), and Chesed (acts of loving kindness). These values are incorporated into daily activities and interactions.

This integrated approach supports the development of:

- Social and emotional intelligence
- Behavioral and problem-solving skills
- Physical health
- Academic readiness and cognitive development

Leadership Circle

The JCYS Leadership Circle, the agency's ongoing leadership development program, provides Board Members and Designates to the Board with comprehensive leadership education throughout the year, including customized trainings, discussions, and hands-on experience as fiduciaries.

SEPTEMBER 27, 2023 - BOARD BASICS

Suzanne Hershman Secler, Vice President of Leadership Development, reviewed responsibilities as detailed in the Board Covenant; discussed the importance of conflict-of-interest policies; and encouraged current Board Members and Designates to grow relationships with alumni, ask difficult questions as fiduciaries, and seek chairperson roles.

OCTOBER 25, 2023 - LEADERSHIP SOCIETY LUNCHEON, SPONSORED IN LOVING MEMORY OF DAVID SCHULMAN BY HIS FAMILY

David Schulman, of blessed memory, dedicated fifty years to JCYS. He had a passion for leadership development, served as a role model and mentor, and instilled in others the importance of not just leading, but teaching others to become leaders themselves. The agency is profoundly grateful that his family chose to sponsor this luncheon as a lasting tribute to David's commitment in nurturing future Jewish communal leaders. This year, Past Presidents and Directors for Life came together to hear a holistic report on the agency by senior leadership and honor David's legacy at JCYS.

OCTOBER 26, 2023 - ONBOARDING A NEW CEO

Ezra Jaffe, Past President, discussed best practices and the board's role in a CEO transition, drawing on his past board experience both at JCYS and other nonprofit organizations. He emphasized the importance of a collaborative Board-CEO partnership through frequent and transparent communication, creating connections with local leadership, and providing opportunities for stakeholders to interact with the new CEO to understand their vision and background.

JANUARY 25, 2024 - COLLABORATION AND COMMUNICATION

The Board profiled their working styles through the DiSC assessment (Dominance, Influence, Steadiness, Conscientiousness). They discussed the best methods of working together and communicating with one another based on their styles and preferences.

FEBRUARY 8, 2024 - JCYS LEADERSHIP DEVELOPMENT BOOT CAMP

Board Members and Designates participated in the fourth annual JCYS Leadership Development Boot Camp, a full day of customized, interactive learning created in partnership with Northwestern University's Kellogg School of Nonprofit Management.

This day of learning and enrichment included lunch with Board Alumni and sessions geared towards experienced board members: Principles of High Performing Boards; The Board's Role in Strategic Planning; Board Evaluation; and Identifying Nonprofit Risk, a fan favorite on the importance of fiduciary oversight.

MARCH 20, 2024 - JCYS FINANCE OVERVIEW

James Arogeti, Treasurer, and Sonya Solomon Piell, CFO, reviewed the fundamentals of nonprofit budgets and audits, focusing on the key differences between nonprofit and for-profit organizations and how to ask relevant questions to further understand financial statements. James also reviewed the risk assessment completed by the finance committee and catalyzed by Boot Camp learnings.






June 1, 2023 - May 31, 2024



JCYS PROGRAM PARTICIPATION




SOURCES OF OPERATING REVENUE*
